The device is to be used exclusively according to its use described in this manual. Use of accessories not recommended by the manufacturer of the device may cause fire, electric shock or injuries.


Marking of a lightning inside a equilateral triangle signifies presence of dangerous voltage, contained under the cover of the device. It may be dangerous for user's life and health.
