Attention! In 4 Mpx resolution camera works only with DAHUA recorders supporting that resolution.



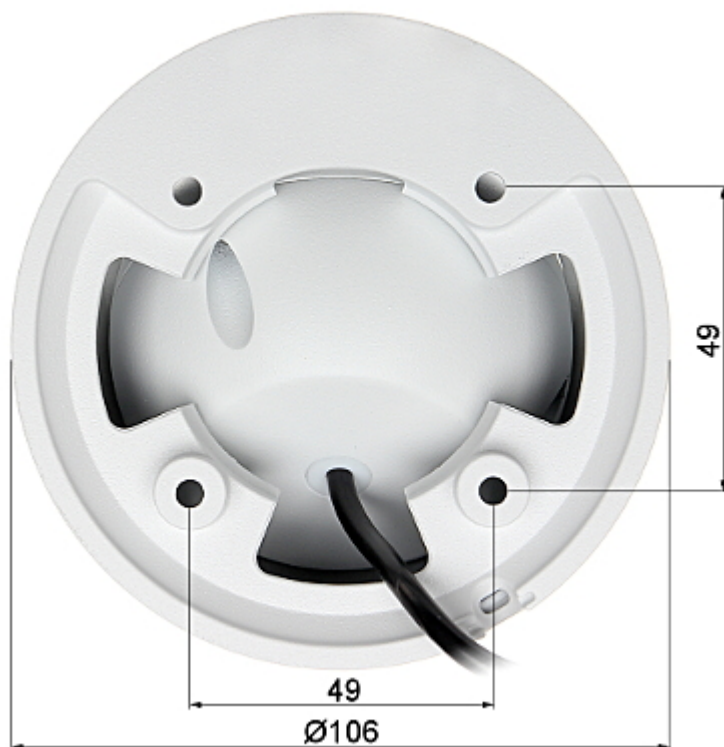

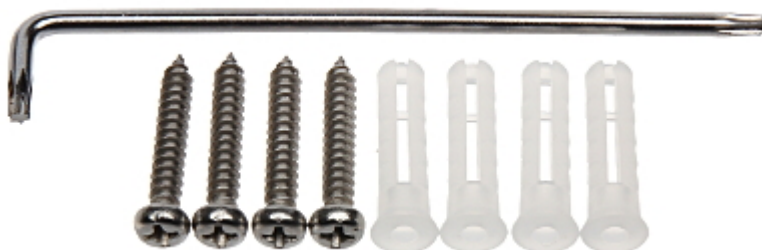
