Turn off the device before transporting it.

Prior to connecting the device to a power source check whether the supplied voltage is consistent with rated voltage specified in the user manual.

### Proper product disposal:

The ACCO-KP controller is designed for control of a single door within the ACCO/ACCO NET access control systems. Users authorization is based on code or passive transponder (proximity card, tag, etc.). The device is provided with a relay output that can be used to operate electromagnetic lock or another door activating device. Owing to additional inputs and outputs, the module can work in conjunction with the alarm system.

The ACCO-KP controller can operate autonomously or in the network mode.

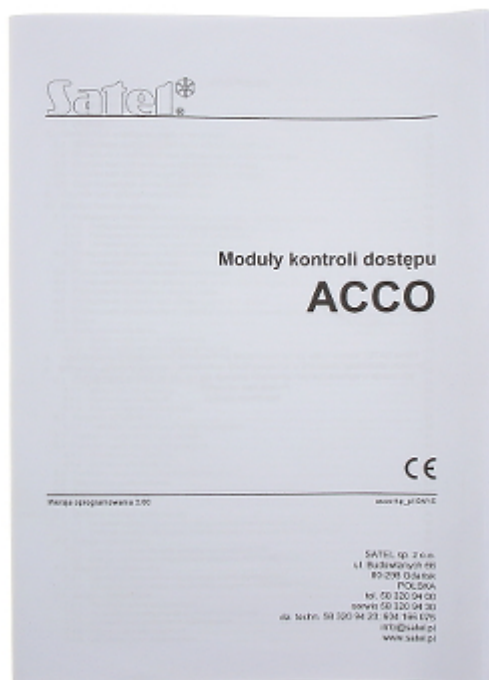
