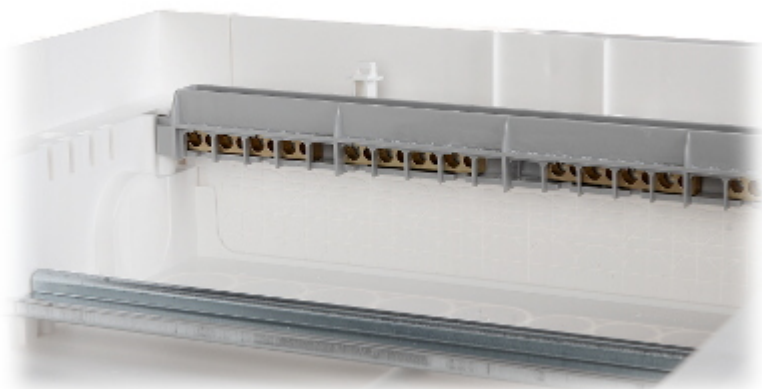

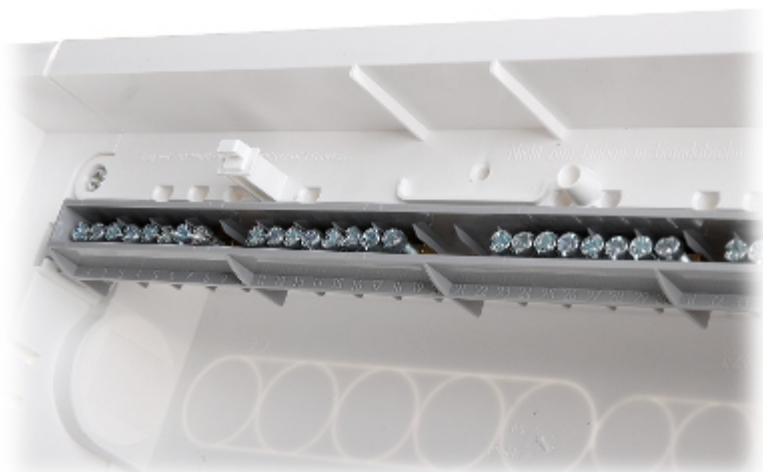
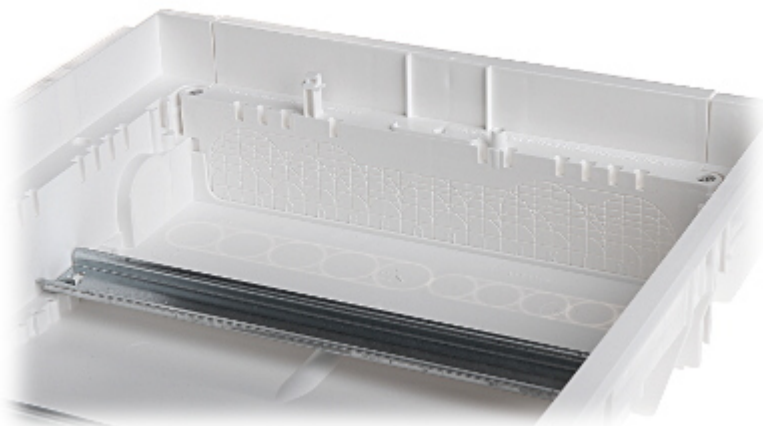
Front view:





Internal view of the housing:



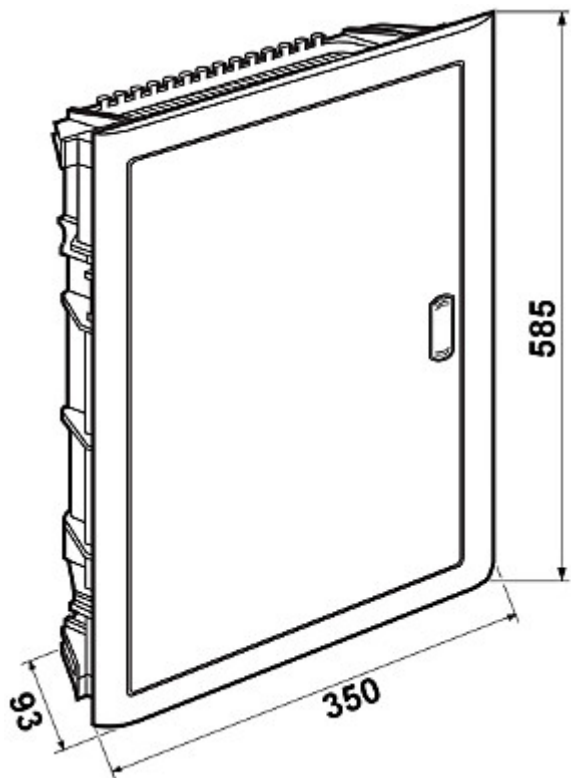


Mounting side view:

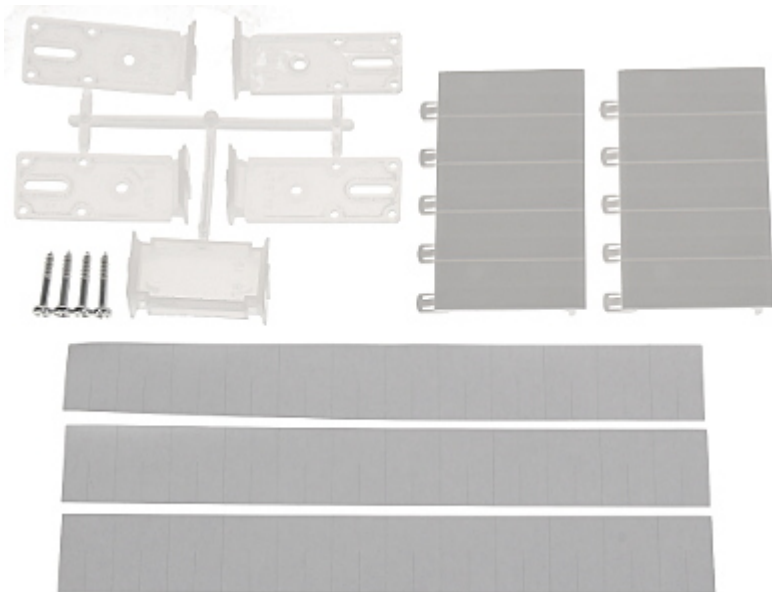
