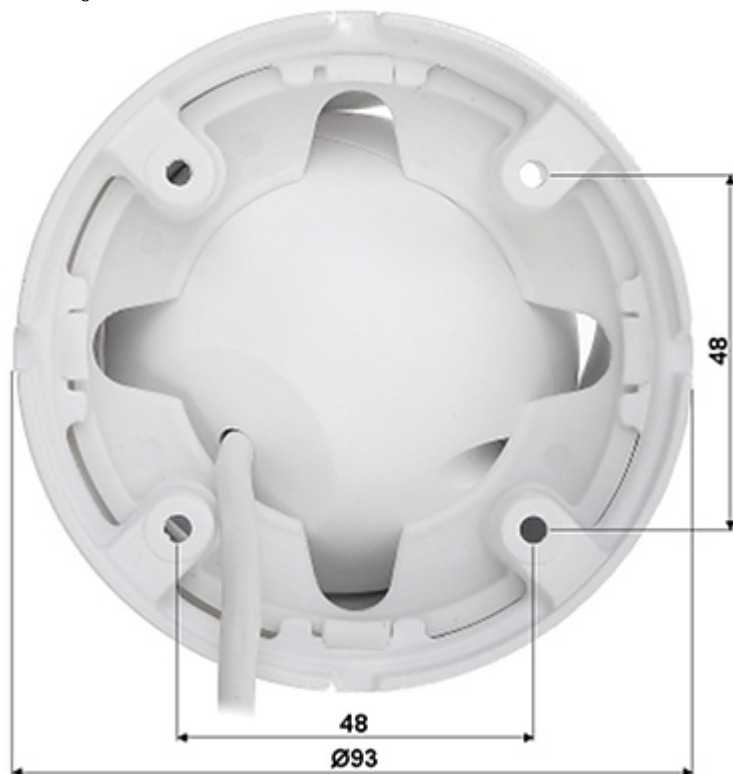

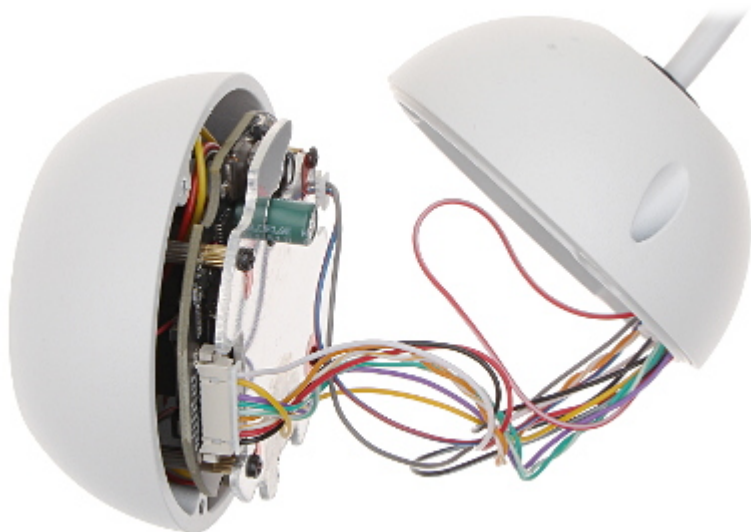

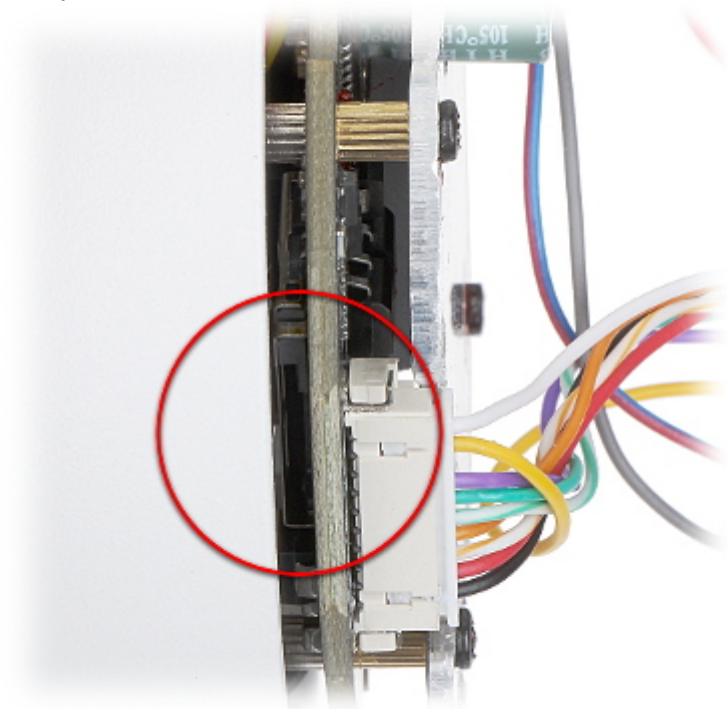
Mounting side view:
