Prior to connecting the device to a power source check whether the supplied voltage is consistent with rated voltage specified in the user manual.

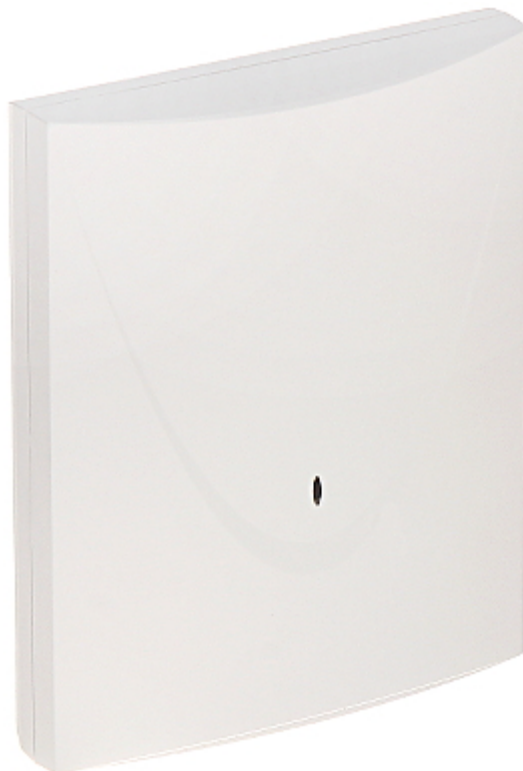
Proper product disposal:

To return a worn-out product, use a collection and disposal system of this type of equipment or contact a seller from whom it was purchased. He will then be recycled in an environmentally-friendly way.

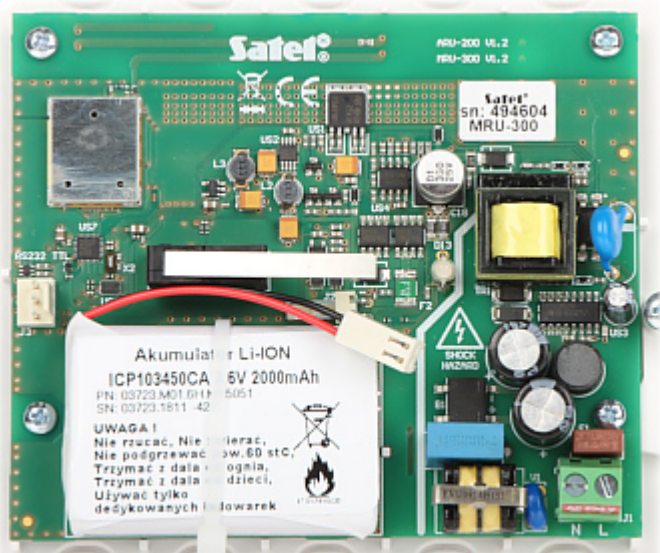
