The AHD / HD-CVI / HD-TVI interface allows to transmission of analog video signal via coaxial cable in 1080p resolution. During transmission there are no delays and is maintained the original, high quality image. Standard changes are made using configuration switches.

In the case of video transmission using a twisted pair cable and matching transformers (balun), be aware of the possibility of signal reflections and interfering signals.

The range of IR illumination according to the manufacturer data, depends on outer conditions (visibility - air transparency, environment, wall colors ie. scene reflectance). Camera is according to IP66 Index of Protection norm.

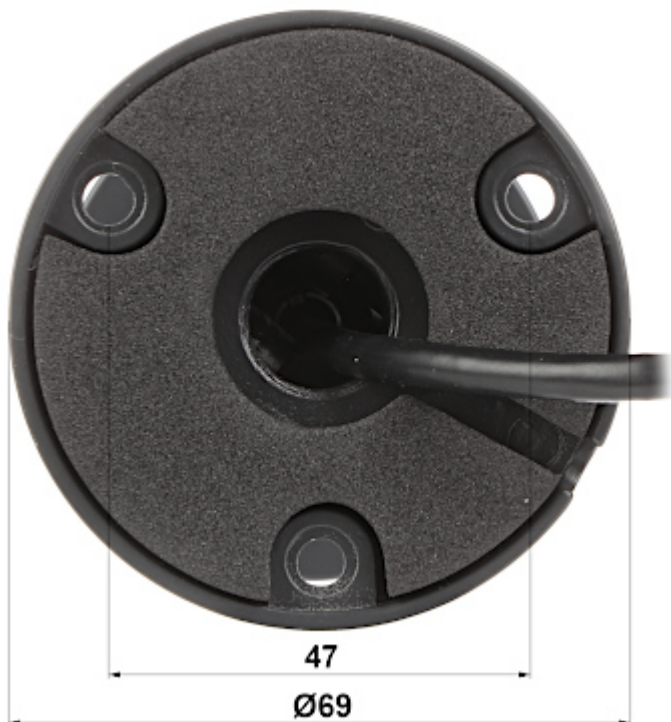
