Prior to connecting the device to a power source check whether the supplied voltage is consistent with rated voltage specified in the user manual.

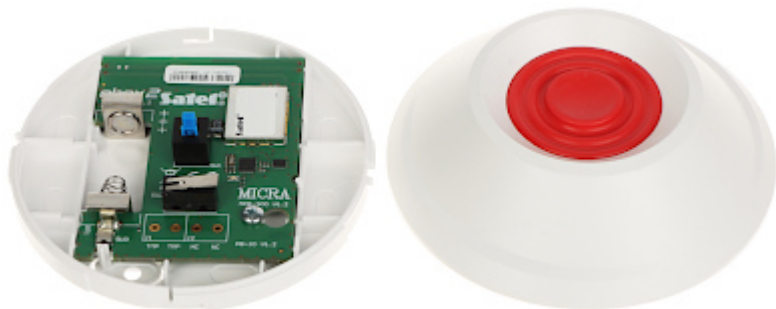

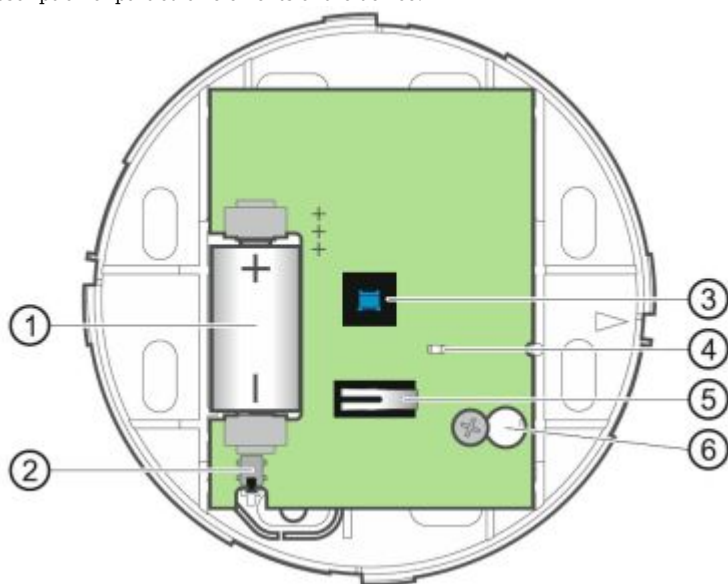
