In the case of video transmission using a twisted pair cable and matching transformers (balun), be aware of the possibility of signal reflections and interfering signals.



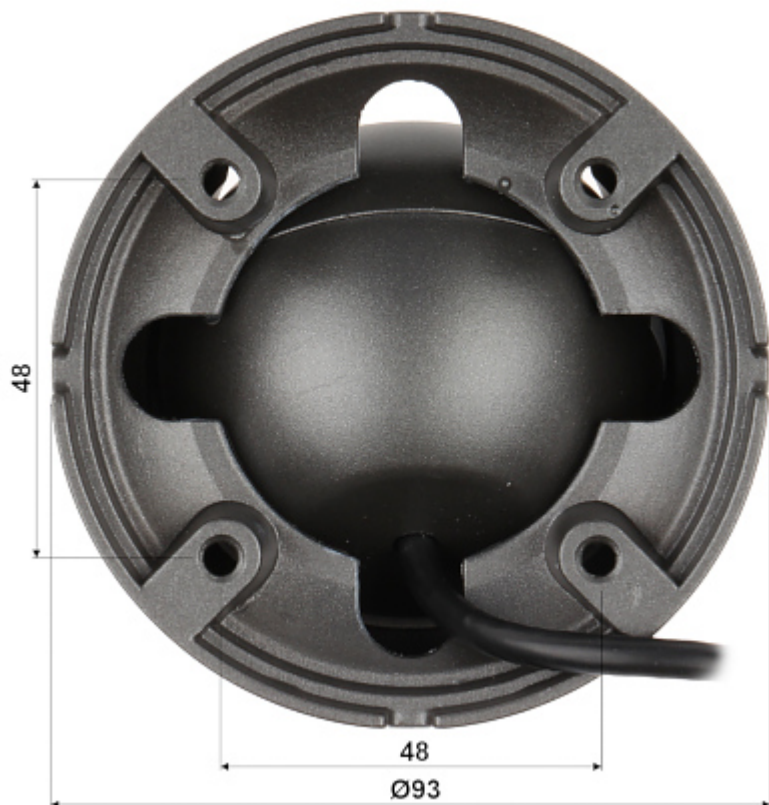
