The employee using RCP Master 4 Web can perform many activities on their own without the need to communicate with the HR department, in particular, check the current state of the worked time, view the event log, submit a holiday request or report other types of absence. The RCP Master 4 Web module enables remote T&A events recording, including remote work recording.

The RCP Master 4 Web application provides also a set of functions intended for superiors of various levels (managers, foremen, team leaders, etc.), who thus gain a quick and convenient way of work time and attendance overview within the managed employees group.





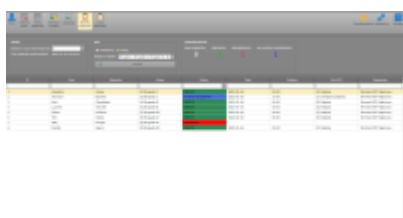
