Attention! We recommend using protections to further protect the device from possible overvoltages in installations. Surge protectors are effective protection against accidental pass to the device voltages higher than the rated. Damages caused by pass the voltages higher than specified in manual, are not under warranty.

Turn off the device before transporting it.

Prior to connecting the device to a power source check whether the supplied voltage is consistent with rated voltage specified in the user manual.

Proper product disposal:

The ASDC-05-050-HS PoE adapter is powered from the PoE 48V line and reduces the voltage to 5V at the $2.1 / 5.5 \, \mathrm{mm}$ output. The basic use of the adapter is to power IP cameras or other devices that do not have the power supply compatible with the PoE standard.

The device can be powered from the PoE 802.3af / PoE 802.3at or PoE PASSIVE switch.
