The F-CUTTER-V2 cutter is designed for quick and convenient cutting of holes in glands integrated with junction boxes. This tool makes it possible to make a hole in the gland with a diameter of  $\emptyset$  7mm,  $\emptyset$  11mm

The design of the cutter makes its use more convenient and safer than using a knife. In addition, the holes made with the tool have an aesthetic, even edge. The cutter also makes it easier to open the box cover.

The user manual must be kept because it may be required in the future. The device is to be used exclusively for purposes specified in this user manual.

The device must be unpacked prior to starting-up. After removing the packaging make sure the device is in working order. If the product has defects, it should not be used until it is repaired.

The product is intended for use at home and commercial use and may not be used for other than intended use.
