Warning!

Please read the user manual included in this work as it contains important information related with safety of installation and use of the device.

Only persons who read the user manual may use the device.

The user manual must be kept because it may be required in the future. The device is to be used exclusively for purposes specified in this user manual.

The device must be unpacked prior to starting-up. After removing the packaging make sure the device is in working order.

If the product has defects, it should not be used until it is repaired.

The product is intended for use at home and commercial use and may not be used for other than intended use.

The manufacturer is not liable for damages resulting from not adhering to the rules contained in the user manual, therefore, we recommend to follow the aforementioned safety rules for operation and maintenance of the device. In this way you will ensure yourself safety and avoid causing damage to the device.

The manufacturer and the supplier are not liable for losses or damages arising out of the product, including financial or intangible losses, loss of profits, income, data, pleasure from use of the product or other products related with it - indirect, incidental or consequential loss or damage. The above provisions apply whether the loss or damage concerns:

Safety measures:

The device was designed in such a way that it restarts operation when power supply is restored after a break.

Turn off the device before transporting it.

Prior to connecting the device to a power source check whether the supplied voltage is consistent with rated voltage specified in the user manual.

Attention! We recommend using protections to further protect the device from possible overvoltages in installations.

Surge protectors are effective protection against accidental pass to the device voltages higher than the rated. Damages caused by pass the voltages higher than specified in manual, are not under warranty.

Proper product disposal:

A marking of a crossed out waste bin indicates that the product may not be disposed together with other household waste in the entire EU. The Green Cell UPS emergency power supply with On-Line topology is characterized by a double conversion of the supply voltage, thanks to which the emergency power supply becomes a protective barrier between mains surges and connected devices. The device is mounted to RACK 19" cabinet.

The UPS14 unit is equipped with AGM Green Cell batteries, which provide stable parameters for the equipment.

Original GC UPS software provides comprehensive capabilities to manage the UPS from the computer.
