### Proper product disposal:

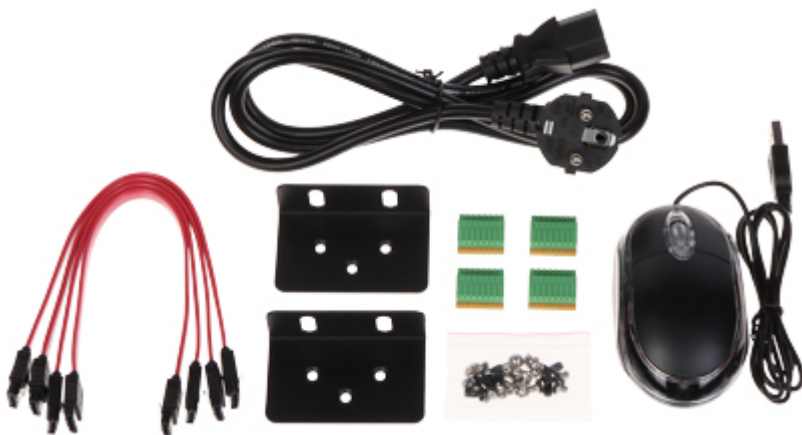
