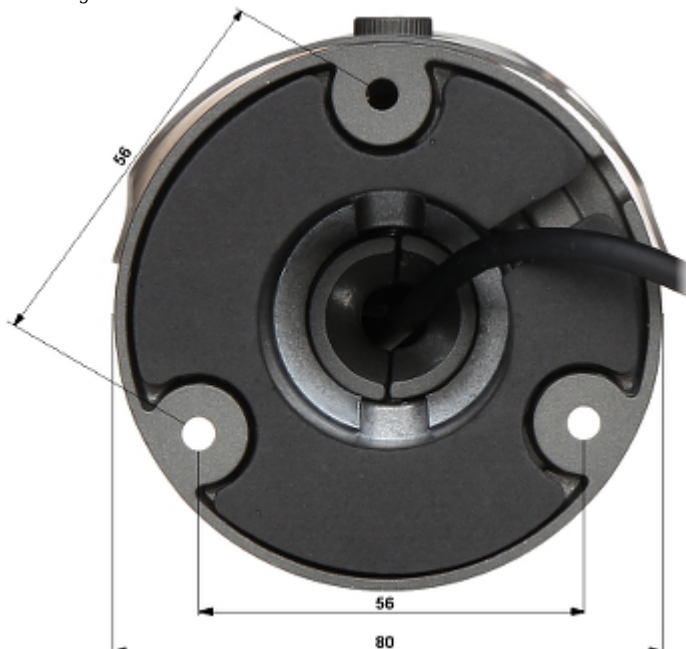

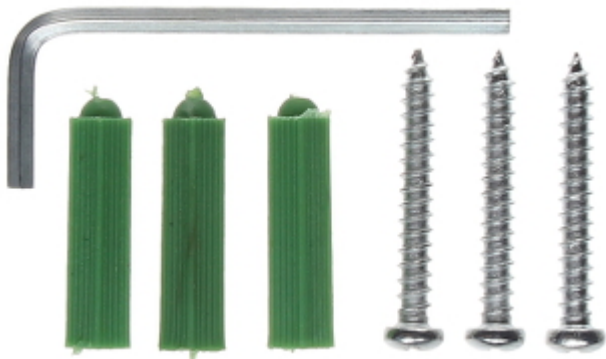
Side view:
